Prescription Drugs on College Campuses: Scope of the Problem

- Rising nationwide epidemic
- In 2012, 21% of Missouri college students used a prescription drug without a prescription.
- Most popular reasons for using without a prescription:
 - Improve academics (45%)
 - Increase energy (41%)
 - Reduce pain (36%)
 - Reduce stress (30%)
 - Enhance mood (26%)

Partnership for Success Plan Overview

- Focus
 - Reducing access to prescription drugs
 - Through prescription drug take back events
 - Increasing education on the issues associated with prescription drug abuse
 - Through social norming media campaigns
 - Through peer education
- Sustainability
 - Training individuals on each campus
 - Existing materials may be reused
 - New 2014 MCHBS prescription drug questions
- Cultural Responsiveness
 - Many campus cultures within PIP
 - Ability to target subpopulations
- Anticipated Outcomes
 - Reduction in prescription drug misuse on PIP campuses
 - Through reduced access
 - Through increased education
 - Increased knowledge on prescription drug misuse at Missouri colleges
 - Through evaluation data
 - Through additional MCHBS questions

MCHBS= Missouri College Health Behavior Survey

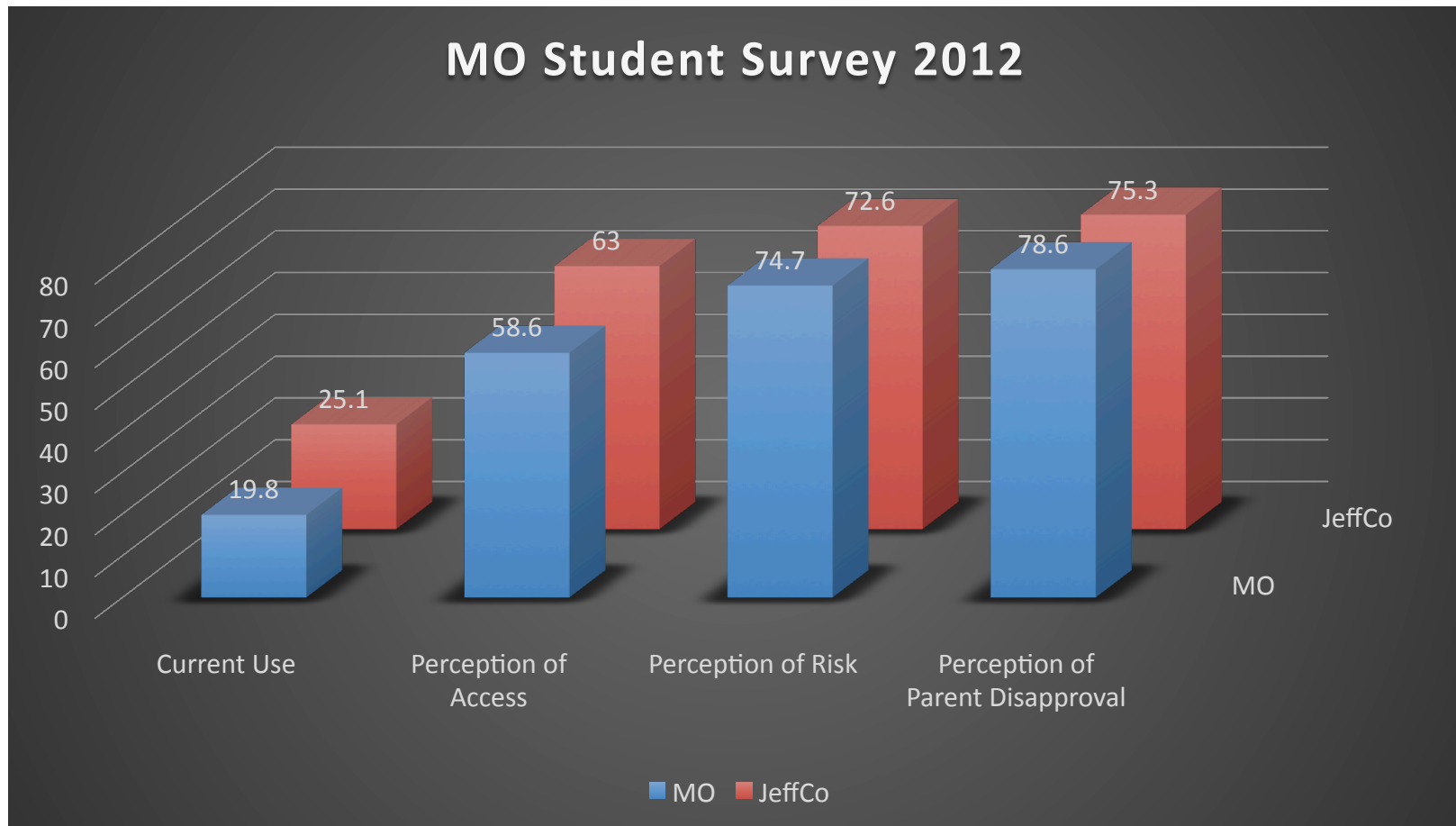




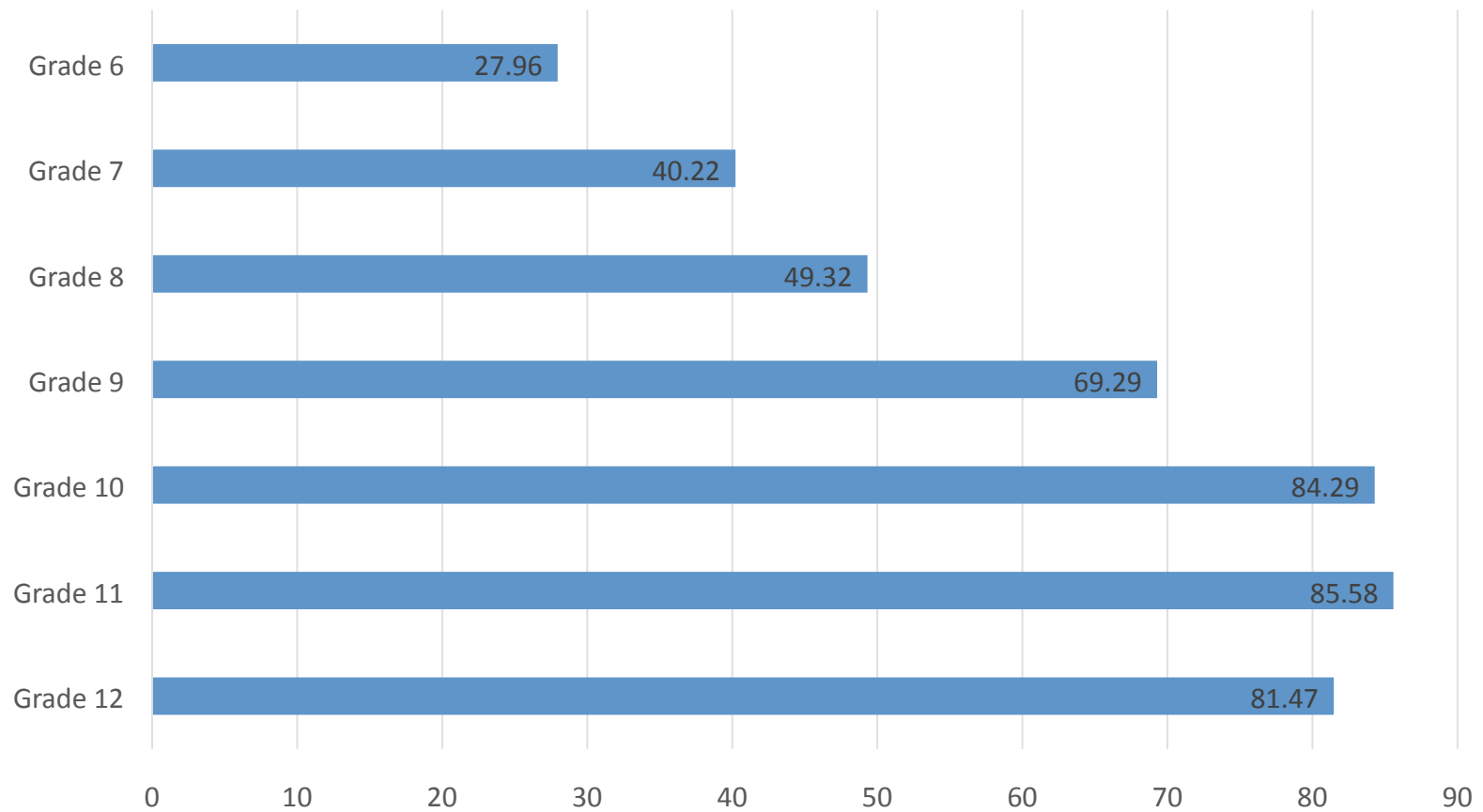

Addressing Underage Drinking in Jefferson County



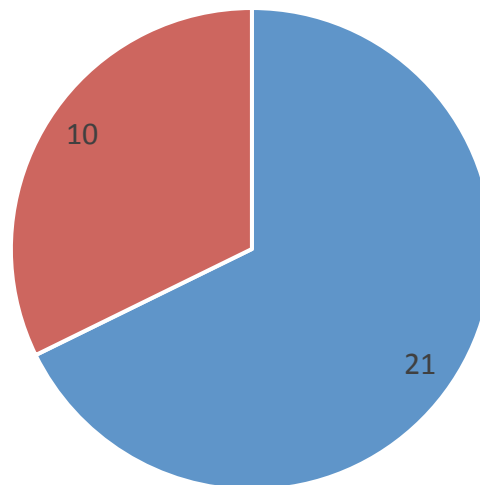
Perception of Ease of Access in JeffCo

Compliance checks conducted by the Jefferson County Sheriffs Department in March, 2013 reported a 32% sell rate to an 18 year old buyer.

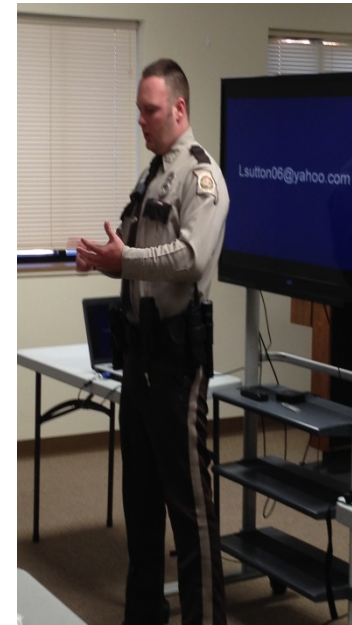

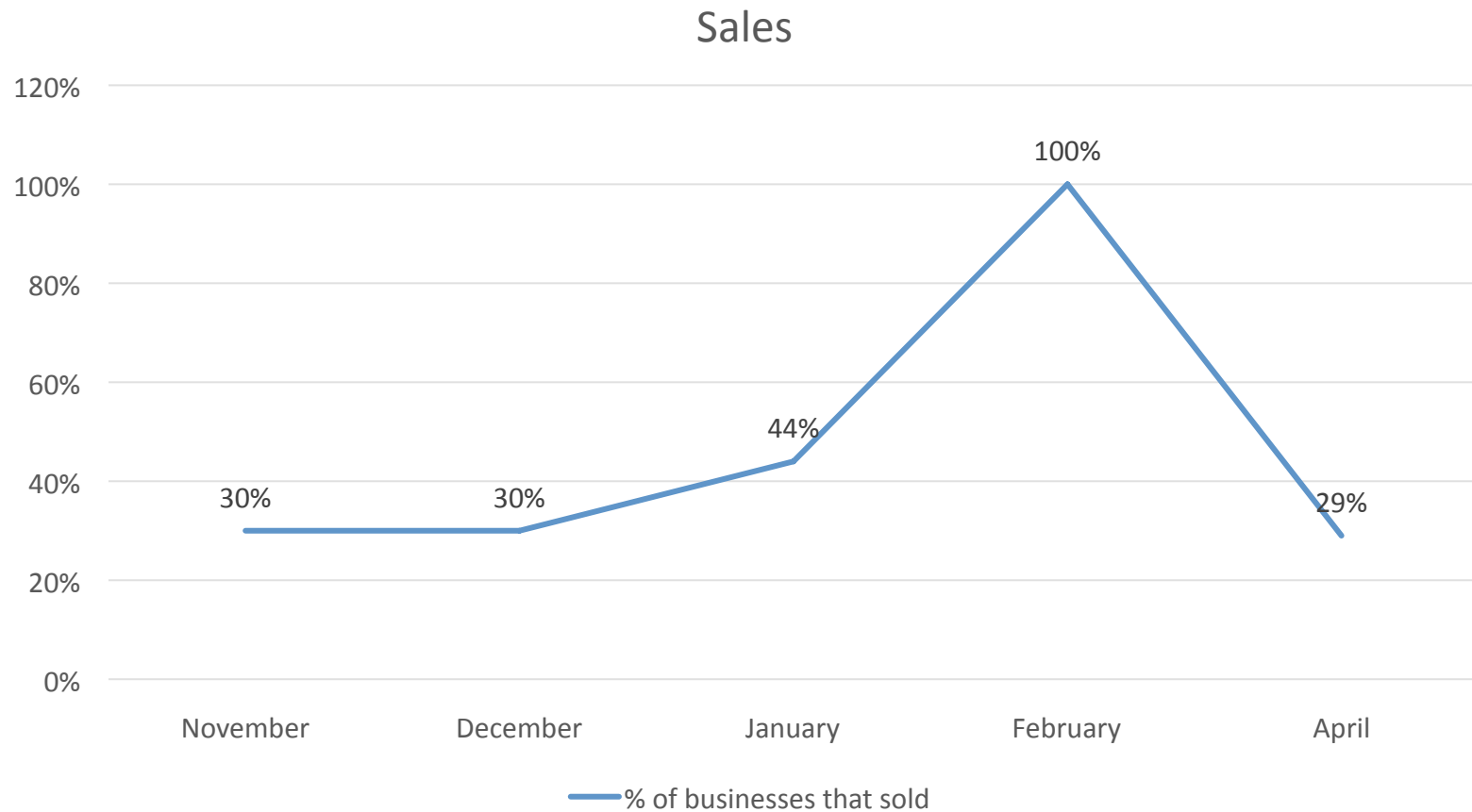

Compliance Check Data

- 34% of attempts result in sales
- Of those that sold, 68% asked to see an ID
- Analysis of contributing factors:
 - Inconclusive Correlations:
 - Number of people in line
 - Time of day
 - Minor gender
 - Minor age
 - Use of secret shoppers
 - In-House Training

Project Focus

- Underage Drinking Prevention Youth Age 12-18
- Nominal Group Process
- Data Collection and Review
- Intervening Variable- Youth Access and Availability

Strategies

- Responsible Beverage Server Certification
 - State of Missouri Alcohol Responsibility Training (SMART)
 - In person RBSC training



- Alcohol Compliance Checks
 - Conducted by Poplar Bluff Police Dept
 - Poplar Bluff alcohol outlets



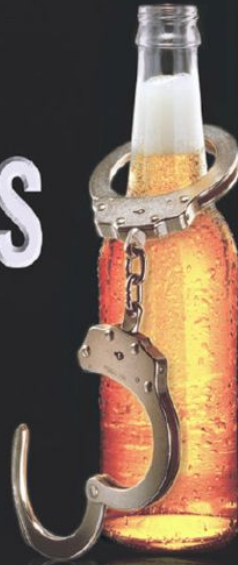
Responsible Beverage Server Certification

- In person training developed by project staff and approved by Missouri Alcohol and Tobacco Control
 - Trainings held January and April 2014, 8 outlets, 30 participants certified
- SMART
 - Web based training, 16 participants representing 3 outlets and project staff
- Vendor Supports
 - Visits from Project Director
 - Binders with training information
 - ID Checking Guide
 - Signage, ID Calendars, billboard advertising, newspaper coverage
 - Technical support

Alcohol Compliance Checks

- Law Enforcement Supports
 - Equipment: Video Recorder and Portable Breathalyzers
 - Funding for overtime pay for officers and pay for youth participants
- Results of Compliance Checks
 - January 2014, 33 checked, 7 failed
 - March 2014, 33 checked, 4 failed, 1 was repeat fail
- Media Messaging
 - Radio Advertisements, Billboard Advertisements
 - Pull Up Banner

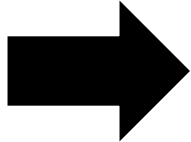

 - Increased Pro-Social Norms

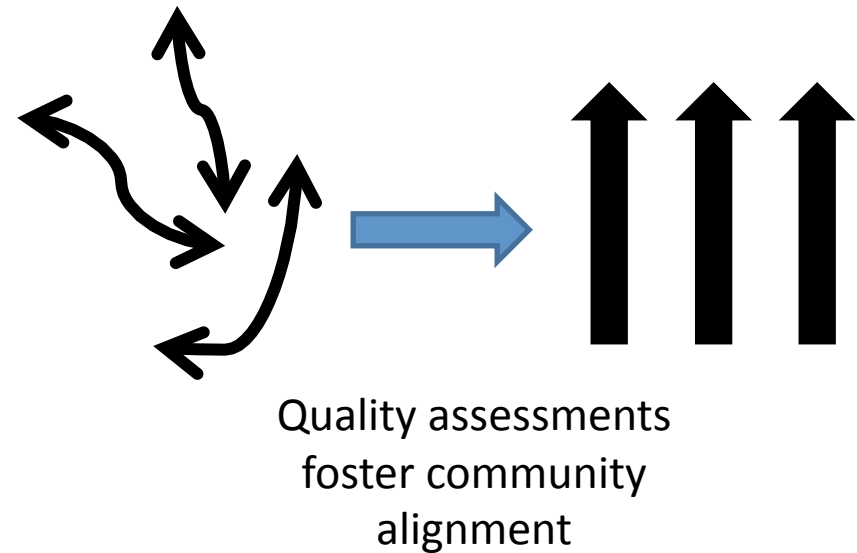
Changing Behaviors

Keys to Partnering for Success

- Ability to convert community assessments into community action plans.
- Leverage resources to support prevention strategies.
- Foster collaboration across multiple sectors of the community.
- Mobilize key stakeholders to advocate for policy change.

Using Assessments to Drive Activity

- Comprehensive community assessments reveal needs and provide a compass for project indicators



Leveraging Resources

- Alignment of key partners fosters alignment of resources around common community outcomes.
- Examples
 - Boone County Alcohol Summit. Collaboration between Youth Community Coalition, MU Wellness Resource Center, and Boone County Health Department
